the Hearing Board may impose reasonable time limits upon statements and presentations.

6. PUBLIC HEARING PROTOCOL

The public is encouraged to participate in the hearing process. The Chair of the Hearing Board will conduct the public hearing through the following actions:

- A. The Chair introduces the hearing item.
- B. The Chair opens the public hearing.
- C. A representative of the issuing Department shall summarize the enforcement case and the contents of the Enforcement Officer's case file shall be admitted into evidence.
- D. Any other reports or written evidence not already provided to the Hearing Board from other County departments or public agencies are acknowledged and made a part of the record. County staff shall summarize the contents of this evidence.
- E. The Chair will ask if any of the Hearing Board Members have questions of staff.
- F. The Responsible Party is given an opportunity to present their arguments and evidence.
- G. The Public is given the opportunity to provide public comment.
- H. The Responsible Party is given an opportunity to present a rebuttal.
- I. After all testimony has been given, the Chair will close the public hearing and the Hearing Board will discuss the matter. During this discussion, the Hearing Board may elect to reopen the hearing to individually ask questions of the Responsible Party, proponent, opponent any other public member, or staff at the convenience of the Hearing Board.
- J. The Chair will entertain a motion and a second.
- K. The Hearing Board will discuss the question.
- L. The Hearing Board will render its decision.

7. DECISION OF THE ADMINISTRATIVE ORDER HEARING BOARD

The ruling of the Administrative Order Hearing Board will be a recommendation that shall be in the form of a written resolution recommending the Board of Supervisors uphold or cancel in whole or in part the Administrative Order as to each violation and or nuisance, and shall list the reasons for their decision.

The written recommendation of the Hearing Board on an Administrative Order shall be considered by the Board of Supervisors at the Board's next available meeting following issuance of the recommendation.

The Board of Supervisors may adopt the recommendation without further notice of hearing, or may set the matter for a de novo hearing before the Board. If the Board adopts the recommendation, the Board's ruling is a final administrative order.
