NOTICE OF PUBLIC HEARING

The Siskiyou Local Agency Formation Commission (LAFCo) will hold a Public Hearing on Tuesday, June 12, 2018, at 3:00 p.m., in the Transportation Conference Room located at 190 Greenhorn Road in Yreka, California on the following item:

SISKIYOU LAFCo FINAL BUDGET FOR FISCAL YEAR 2018-2019

Pursuant to California Government Code Section 56381, Siskiyou LAFCo will consider adoption of its final budget for fiscal year (FY) 2018-2019. It is anticipated that adoption of the final budget for FY 2018-2019 will be determined to be exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of the CEQA Guidelines (i.e., the "general rule exemption"). A "general rule exemption" implies that the project will not result in any significant adverse environmental effects. Siskiyou LAFCo will consider the appropriateness of said environmental recommendation based on the record of evidence before them. If substantial evidence has been presented demonstrating a more appropriate environmental determination than the one that has been recommended, Siskiyou LAFCo may require and/or approve an alternative environmental determination pursuant to the requirements of CEQA.

LAFCo's final budget documents for FY 2018-2019 are on file in the Siskiyou County Community Development Department for public review, and all interested persons are invited to attend the Siskiyou LAFCo meeting and be heard on any agenda item. Please contact Christy Cummings Dawson, Deputy Executive Officer of Siskiyou LAFCo, at the Siskiyou County Community Development Department, 806 S. Main Street, Yreka, CA if you have any questions regarding the budget.

If you challenge the CEQA exemption and/or Siskiyou LAFCo's Final Budget for FY 2018-2019 in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to Siskiyou LAFCo at or prior to the public hearing.
