RESOLUTION NO.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE SISKIYOU COUNTY AIR POLLUTION CONTROL DISTRICT TO COMMENCE POST-RETIREMENT EMPLOYMENT WITHIN THE EXCEPTION TO THE 180-DAY WAIT PERIOD PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTIONS 7522.56 & 21224

WHEREAS, in compliance with Government Code section 7522.56(f)(1) the Siskiyou County Air Pollution Control District must provide CalPERS with a certification resolution when hiring a retiree before 180 days has passed since his or her retirement date certifying that the nature of the employment and that the appointment is necessary to fill a critically needed position; and

WHEREAS, Eric Olson, retired from the Siskiyou County Air Pollution Control District from the position of Air Pollution Specialist III, effective November 30, 2024; and

WHEREAS, section 7522.56(f)(1) requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is June 1, 2025 without this certification resolution; and

WHEREAS, section 7522.56(g) provides an exception to the 180 day wait period where the employer certifies the nature of the employment and that the appointment is necessary to fill a critically needed position before 180 days have passed and the appointment has been approved by the governing body of the employer in a public meeting; and

WHEREAS, section 7522.56(g) provides that this exception to the 180 day wait period shall not apply if the retiree accepts any retirement related incentive; and

WHERAS, the Siskiyou County Air Pollution Control District Board of Directors and the Air Pollution Control Officer certify that Eric Olson holds critical skills and knowledge that is needed to operate, maintain and update District monitoring and reporting equipment, and enforce the Air Quality laws and regulations. This is a critical position necessary to the Operations of the Siskiyou County Air Pollution Control District; and

WHEREAS, the Siskiyou County Air Pollution Control District Board of Directors, and the Siskiyou County Air Pollution Control Officer certify that Eric Olson has not and will not receive any retirement related incentives prohibited under section 7522.56(9); and

WHEREAS, the Siskiyou County Air Pollution Control District Board of Directors hereby appoints Eric Olson as an extra help retired annuitant to perform the duties of the Air Pollution Specialist III for the Siskiyou County Air Pollution Control District under Government Code section 21224, effective February 16, 2025; and

WHEREAS, the entire appointment document between Eric Olson and the Siskiyou County Air Pollution Control District Board of Directors has been reviewed by this body; and

WHEREAS, no matters, issues, terms or conditions related to this employment appointment have been or will be placed on a consent calendar; and

WHEREAS, the employment shall be limited to 960 hours per fiscal year; and

WHEREAS, the compensation paid to retirees cannot.be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal. the hourly rate; and

WHEREAS, the maximum base salary for this position is \$6,337.07 and the hourly

equivalent is \$36.56 and the minimum base salary for this position is \$4,962.53 and the hourly equivalent is \$28.63; and

WHEREAS, the hourly rate paid to Eric Olson will be \$36.56; and

WHEREAS, Eric Olson has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate; and

THEREFORE, BE IT RESOLVED THAT the Siskiyou County Air Pollution Control District Board of Directors hereby certifies the nature of the appointment of Eric Olson as described herein and detailed in the attached employment agreement/contract/appointment document and that his appointment is necessary to fill the critically needed position of Air Pollution Specialist III for the Siskiyou County Air Pollution Control District by January 28, 2025 for the following reasons:

- 1. Eric Olson is the only Siskiyou County Air Pollution Specialist III employee who possesses the skills and knowledge to train his successor in the use of all specialized equipment, data collection and analysis requirements, enforcement processes and operate, maintain, update and report as required by law prior to and as training occurs.
- 2. Mr. Olson will be able to help the new employee with training to obtain the required skills and knowledge that is needed to operate, maintain, update and report, and enforce the law in as required by law.

Air Pollution Control District Minutes, October 28, 2024

The Honorable Directors of the Air Pollution Control District Board of Siskiyou County, California, met in special session this 28th day of October 2024; there being present Directors Ray Haupt, Ed Valenzuela, Michael N. Kobseff and Julianna Lucchesi, Deputy District Counsel Dana Barton and County Clerk and ex-Officio Clerk of the Air Pollution Control District Laura Bynum by Deputy County Clerk Wendy Winningham. Directors Brandon Criss and Pat Vela were absent.

The meeting was called to order by Chair Lucchesi. Director Lucchesi led in the salute to the flag of the United States of America.

Air Pollution Control District Governing Board - Election of Chair and Vice Chair for 2024. Directors Lucchesi and Kobseff elected Chair and Vice Chair, respectively.

It was moved by Director Kobseff, seconded by Director Valenzuela and carried, following a roll call vote with Directors Haupt, Valenzuela, Kobseff and Lucchesi voting YES and Directors Criss and Vela ABSENT to elect Director Lucchesi as Chair for 2024 and Director Kobseff as Vice Chair for 2024.

Presentations from the Public

There were no public comments received.

Transfer of Funds – Air Pollution Control District - \$65,000. Resolution APCD 24-01 adopted.

Following a brief overview of the request from Air Pollution Control Officer Jim Smith, it was moved by Director Valenzuela, seconded by Director Haupt and carried, following a roll call vote with Directors Haupt, Valenzuela, Kobseff and Lucchesi voting YES and Directors Criss and Vela ABSENT to adopt Resolution APCD 24-01, Transfer of Funds – Air Pollution Control District, in the amount of \$65,000.

Air Pollution Control Officer – Presentation of an update re various District activities/concerns, including air monitoring in the Copco area, financing, Department staffing, upcoming retirement and the need for Hearing Board members/volunteers.

Air Pollution Control Officer Jim Smith appeared before the District Board and provided an update regarding portable air monitors being utilized at the Copco Lake area to sample dust in the air. Mr. Smith shared concerns regarding the lack of funding to allow testing/sampling for heavy metals that may be released into the air and the possible use of unregulated wheat seeds being planted as cover crops in/around the former lake bed. Mr. Smith further shared concerns regarding the potential negative impact to the Department's staffing upon retirement of their current Air Quality Specialist Eric Olson. Mr. Smith advised that the Air District anticipates award of an Environmental Protection Agency (EPA) grant that will provide funding to operate equipment and that he would research methods for continuing air quality testing/sampling and reporting to the EPA following Mr. Olson's retirement.

Discussion followed between District Board members, Mr. Smith, District Counsel Dana Barton and Deputy County Administrator-Personnel Manager Hayley Hudson regarding the anticipated dates for Air Pollution Control District meetings, the methods for finalizing those meeting dates and the need to coordinate with County Personnel regarding a possible CalPERS exemption for Mr. Olson to continue following retirement.

County Clerk - Appointment of five members to the scheduled vacancies on the Air Pollution Control District Hearing Board for Medical, Engineer and Attorney representatives and two General Public representatives, with three-year terms ending January 1, 2027; January 19, 2027; January 28, 2027 and March 16, 2026, respectively. Holly Lenz appointed for Medical representative position.

Deputy County Clerk Wendy Winningham provided an overview of the request, advising that local resident Holly Lenz was interested in filling the Medical representative position on the Air Pollution Control District Hearing Board. In addition, Ms. Winningham requested continuation of the remaining vacancies.

It was moved by Director Haupt, seconded by Director Valenzuela and carried, following a roll call vote with Directors Haupt, Valenzuela, Kobseff and Lucchesi voting YES and Directors Criss and Vela ABSENT to appoint Holly Lenz to the scheduled vacancy on the Air Pollution Control District Hearing Board, Medical representative, with a term ending January 1, 2027.

Minute Approval - December 5, 2023 and July 9, 2024. Approved.
