Rescind existing use permit (UP-96-03) and create new use permit (UP-23-08). The new use permit (UP-23-08) will forgo church operations but will increase the permitted occupancy to 225 students and 35 staff. An additional modular classroom is proposed as part of this proposal, totaling 960 square feet, and an additional school building is proposed as part of this proposal, totaling 28,300 square feet. The project was approved, on appeal, with an Addendum to the prior existing MND.
