Project Title: Wastewater Treatment Plant Improvements Project

Project Applicant: City of Yreka

Project Location: The Wastewater Treatment Plant (WWTP) and disposal fields are located generally east of State Route (SR) 263 (North Main Street), west of Yreka Creek, and north of SR 3 (Montague Road). Lift Station (LS) 1 is located northwest of the intersection of Helweg Court and SR 3; LS 2 is located north of SR 3, ~370 feet east of Quarry Court; LS 3 is located on the east side of North Phillippe Lane, ~0.3 miles north of SR 3; and LS 4 is located on the west side of South Phillippe Lane, ~0.3 miles south of SR 3 (see Figures 1-4 in the IS/MND). The subject properties are not included on any list of hazardous waste facilities/sites pursuant to Section 65962.5 of the California Government Code.

Project Description: The project entails improvements to the City of Yreka's WWTP, wastewater disposal fields, and Lift Stations (LS) 1, 2, 3, and 4. Improvements at the WWTP include upgrades to the headworks; replacement of surface aerators and diffusers; improvements to the secondary clarifiers; electrical improvements; installation of a fiber optic line from the corporation yard to the control building; expansion and renovation of the control building; demolition of the chlorine contact basin, filtration facility, and SOMAT facility; construction of a new disinfection facility and a new filtration building; installation of a sludge dewatering facility; replacement of the lift station; and installation of supervisory control and data acquisition (SCADA) equipment. Improvements in the disposal fields include replacement of the control building, moisture sensors, solenoid control valves, and concrete valve boxes, installation of new electrical conduit and pull boxes, and installation of a roof-mounted antenna on the new control building. At the lift stations, antennas on ground-mounted poles, cables, and radios would be installed, and minor modifications would be made to the existing control panels to support the SCADA system. *Additional details about the proposed project are included in Section 3.0 (Project Description) of the Initial Study.*

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF YREKA ADOPTING A
MITIGATED NEGATIVE DECLARATION AND
MITIGATION MONITORING AND REPORTING PROGRAM FOR THE
WASTEWATER TREATMENT PLANT IMPROVEMENT PROJECT**

WHEREAS, in accordance with California Public Resources Code Division 13 (California Environmental Quality Act [CEQA]), and California Code of Regulations Title 14, Division 6, Chapter 3 (CEQA Guidelines), an Initial Study and Mitigated Negative Declaration (IS/MND) for the City of Yreka (City) Wastewater Treatment Plant Improvement project (project) were prepared and made available to the general public and interested agencies for a 30-day review period; and

WHEREAS, the City published a Notice of Availability/Notice of Intent to Adopt the IS/MND in the local newspaper and submitted the notice and IS/MND to the State Clearinghouse (SCH No. 2024070645) for circulation to State agencies. The local public review period and the agency review period managed by the State Clearinghouse ended August 19, 2024; and

WHEREAS, the City Council conducted a duly noticed public meeting on September 17, 2024, at which time comments regarding the environmental determination for the project were considered; and

WHEREAS, the custodian of the documents and all other materials that constitute the record of proceedings upon which the City based its decision regarding adoption of a MND for the project is the City of Yreka, located at 701 Fourth Street, Yreka, California.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. The City Council hereby finds and determines that:
 - a. The foregoing recitals are true and correct.
 - b. The IS/MND provides a comprehensive evaluation of the project, adequately describes potential impacts to the environment, and was prepared in accordance with the requirements of CEQA and the CEQA Guidelines.
 - c. Based on the whole record (including the IS/MND, comments submitted to the City, and all supporting documentation), and the mitigation measures incorporated into the project, the City Council has determined that there is no substantial evidence in the record that the project will have a significant effect on the environment.
 - d. The MND, with its supporting documentation, reflects the independent judgment and analysis of the City, which is the CEQA lead agency for the project.
 - e. The monitoring and reporting of CEQA mitigation measures for the project will be conducted in accordance with the attached Mitigation Monitoring and Reporting

Program (MMRP). Adoption of the MMRP constitutes fulfillment of the CEQA monitoring and reporting requirements set forth in §15074(d) of the CEQA Guidelines.

2. The City Council hereby adopts an environmental determination of Mitigated Negative Declaration pursuant to §15074 of the CEQA Guidelines, finding that the project will not have a significant adverse effect on the environment that could not be mitigated.
3. The City Council hereby adopts the attached MMRP pursuant to §15074(d) of the CEQA Guidelines.




