
This is to advise that the Planning Commission of the City of Weed as Lead Agency, on December 18, 2024, approved the above-described project to grant a conditional use permit for an 3,488 sq ft Arco AM/PM with 6 double-sided fueling stations under a canopy and a 2,100 sq ft quik serve restaurant with drive-through; and determined the project to be exempt from further environmental review requirements contained in the California Environmental Quality Act (CEQA).

REASONS TO SUPPORT EXEMPTION FINDINGS: The project site is zoned as C-2 and its General Plan land use designation is Commercial. The proposed project, which seeks a conditional use permit to operate a service station on a C-2 zoned site, aligns with the zoning requirements and would be consistent with the C-2 zone district if approved. The proposed project would also support the City's General policies for the South Weed area such as Policy CI 1.8.1 which states to maintain the status of South Weed Boulevard as the primary truck route through the City; Policy ED 1.5.2 states the City shall prioritize infill commercial development along South Weed Boulevard west of I-5 and Policy LU 1.1.1 stated to promote a diverse mix of commercial services in the South Weed area.
