2. Current reporting; Discussion.

Chief Coley talked about the previous discussions by CCP members on the importance of data collection and reporting that information to support the work that CCP partners do. He shared information about the Annual CCP survey which is due every December. The report currently includes who the CCP members are and what their plan is for the upcoming year. He suggested that collecting more data and including that information in the survey could enhance the report. Finally, he shared the Probation Department's Annual report, which includes an overview of both the Adult and Juvenile Divisions, drug testing, historical data, other programs such as Pre-Trial, and includes various graphs to support the data. Once the report is completed, he will share with everyone.

Chief Coley shared that he heard and appreciated Ms. Kayfetz's department report to the Board of Supervisors and how important the roll of the Public Defender's office is in rehabilitation, reducing jail time and getting clients assistance and resources. Ms. Kayfetz shared about her meeting with Program Coordinator Erin Welch and coming up with additional data points that could be collected and reported out, specifically how CCP funds are being spent. Discussion ensued regarding how to begin collecting this information. Members decided to have Ms. Welch meet with departments to assess current goals, identify new goals and determine the best path to meet those goals. It was hopeful she could have information to present by the next CCP meeting in September.
