Beginning July 15, 2024, nomination papers may be obtained in the office of the County Clerk, 311 Fourth Street, Room 201, Yreka, or by calling the County Clerk's Office at 530-842-8084. Completed forms must be filed in the office of the County Clerk at the above address no later than 4:00 P.M. on August 9, 2024.

EXCEPTION: The filing period will be extended until 4:00 P.M. on August 14, 2024, if an incumbent, eligible for reelection, fails to file a declaration of candidacy by 4:00 P.M. on August 9, 2024. There is no extension of the nomination period for an office where there is no incumbent eligible to be reelected.

If, by 4:00 P.M. on August 14, 2024, no person has been nominated or only one person has been nominated for each vacant position and a petition signed by 10 percent of the voters or 50 voters, whichever is the smaller number, in the district requesting that a school district election be held for the offices has not been presented to the County Clerk, appointment will be made as prescribed by Education Code §5328.

In order to qualify for the office of Governing Board Member a person must be a registered voter in the district, or trustee area if elected by trustee area.

In addition, any registered voter is eligible to be a member of the County Board of Education except the County Superintendent of Schools, any member of his/her staff, or any employee of a school district.
