Notice is Hereby Given that the Siskiyou County Local Agency Formation Commission (Siskiyou County LAFCo) will hold a Public Hearing on **Tuesday, September 10, 2024, at 9:00 a.m.** in the Board of Supervisors Chambers, 311 Fourth Street, 2nd Floor, Yreka, California, on the project described below.

Siskiyou County LAFCo Fire Protection Municipal Service Review and Sphere of Influence Update

Siskiyou County LAFCo will consider and adopt the Fire Protection Municipal Service Review (MSR) and Sphere of Influence (SOI) Update. This review encompasses cities, fire protection districts, Community Service Districts (CSD), hose companies, Zones of Increased Benefit (ZIB), and County Service Area's (CSA). The purpose of this MSR is to perform a comprehensive update and review of the current service levels provided by the fire service providers in the County.

Siskiyou County LAFCo's Fire Protection MSR and SOI update documents for FY 2024/2025 are on file in the Siskiyou County LAFCo office which is within the Planning Division of the Siskiyou County Community Development Department, 806 South Main Street, Yreka, California, 96097, and are available for public review upon contacting the staff planner. A staff report and all attachments will be available for public review three working days prior to the LAFCo meeting either at the Siskiyou County LAFCo office or online on the Siskiyou County LAFCo [meeting page](#).

All items presented to Siskiyou County LAFCo during a public hearing, including but not limited to, letters, e-mails, petitions, photos, or maps, become a permanent part of the record and must be submitted to the Clerk of the Commission. It is advised that the presenter bring 12 copies of anything presented to the Commission and that the presenter create copies in advance for their own records.
