

Upland Management Evaluation: Scott Valley Watershed and Shasta Valley Watershed Prescribed Burns or Timber Harvests, as of July 2024 With Stream Gauge and Snow Record

This table lists prescribed burns or timber harvests that have occurred in the Scott Valley Watershed or Shasta Valley Watershed since the year 2000. Only prescribed burns or timber harvests that have occurred upstream of a stream gage with measurement before and after the burn/harvest are included. The intent is to identify prescribed burns or timber harvests and determine whether historic stream data can be used to evaluate the impact of the event on streamflow.
